UPDATE ON SECTION 406 FEDERAL IPM FUNDING

- Regional Pest Management Centers will be funded at \$2,994,000 (down from \$4,096,000 in FY 2010). Current understanding is that a competition is required for distribution of the one year of Regional IPM Centers funds, and that successful applicants will probably budget to maintain operations (with the single year of funding and a potential one year no-cost extension) through August of 2013.
- Methyl Bromide Transition Program funding reduced from \$3,054,000 to \$1,996,000.
- Organic Transition Program funding reduced from \$5,000,000 to \$3,992,000.
- Crops at Risk (CAR) program eliminated. <u>View abstracts for previously funded CAR</u> projects.
- FQPA Risk Mitigation and Avoidance Program (RAMP) eliminated. <u>View abstracts for previously funded RAMP projects.</u>
- Critical Issues Programs eliminated. <u>View abstracts for previously funded Critical Issues projects.</u>
