## IPM Voice Builds the Case for IPM in the Farm Bill

US Farm Bill legislation sets agricultural policy for the next four years. For the first time, IPM has an organization dedicated to delivering a message about the importance of IPM in reducing pest problems, pesticide risks and long-term costs.

During the first week in March, Jim Cubie, IPM Voice's legislative representative, and Dr. Tom Green of the IPM Institute presented IPM Voice's legislative agenda to Congress. The IPM Voice Board of Directors chose five Farm Bill initiatives which were heard by all the key committees writing the Farm Bill. These initiatives are designed to increase the financial support for IPM and affirm IPM's role as an essential system which provides comprehensive solutions to the pest management challenges faced by farmers and others.

#### **IPM Voice Initiatives:**

- 1. Amend the Agriculture and Food Research Initiative (AFRI) to include all IPM tools. AFRI is the basic USDA external research program. The statute now lists only "biocontrol" which is one of many IPM tools.
- 2. Establish the position of "National IPM Coordinator" to facilitate regional and multi-agency initiatives.

- 3. Provide legislative authorization for the Regional IPM Centers.
- 4. Amend the National Institute of Food and Agriculture statute to create a positive obligation for the Secretary to continue to assist producers in adapting to changes in the availability of pesticides due to regulatory or voluntary industry changes. NIFA is the agency that has overall responsibility for USDA external research activities.
- 5. Allow the Secretary to waive cash match requirement for applied research if it is of national importance.

On the Senate and House agriculture committees, staff are designated to handle research including IPM. We met with 12 key staff members from both parties. We gave each member a fact sheet on the importance of IPM to US agriculture and a fact sheet that describes how important IPM is to the state for which they have specific responsibility. We pointed out that the USDA's 2013 budget only mentioned one IPM initiative that has saved farmers \$1 billion (IPM PIPE for Asian Soybean Rust). We are now following up, providing additional information that members requested. Much work needs to be done but we have reason to hope that all or part of the IPM legislative agenda will become part of the Farm Bill.

At the same time we are working to build broader support for IPM. The National Association of Independent Crop Consultants has endorsed our legislative agenda and we are working hard to convince specialty crop organizations to support it as well.

You are a critical part of this process. Being heard for the first time is a big step - but now that the importance of IPM is understood we need to make it a priority. To get that done, IPM Voice needs your help. If you have had any contact with the offices of the <a href="House">House</a> and <a href="Senate">Senate</a> Committees on Agriculture including Congressional Members or Senators we would like to know. We understand that universities have restrictions on contact with Congressional offices and will make sure that those restrictions are honored. # **Proposed Crop Protection Program Would Allow Indirect**

In the President's proposed budget, funds formerly designated for the IR-4 Minor Crop Pest Management Program, E-IPM - State-based IPM Coordinators, Regional IPM Grants Program and the Expert IPM Decision Support System are combined into a new Crop Protection Program. USDA National Institute of Food and Agriculture (NIFA) plans a series of listening sessions (see article below) to develop this new concept further. An important implication of the new proposal is that all funding would be subject to 30% indirect cost recovery by the host land-grant institution. Currently, only the Regional IPM Centers and the Pest Management Alternatives Program are subject to indirect costs. The proposed indirect cost translates into a potential 30% cut in available funding for implementation. IPM Voice is working to educate stakeholders and policymakers about these potential impacts, which would be devastating to IPM programs which have already been subject to disproportionate reductions in funding over the past decade, and especially since 2010.
